Sub: Mpl Admn Dept- Release of 15th Finance Commission Grants and State Matching Grants Under Pattan Pragati-utilisation of grants - Certain instructions issued-Reg.

Ref: 1. This Office Lr.Roc.No.195263/2020-H2, Dt.02.06.2020 addressed to all the Municipal Commissioners.

The attention of all the Municipal Commissioners in the state are invited to the references cited, wherein in the reference 1st cited, an amount of Rs.105.25 Crs has been released as 1st installment of Basic Grant for the F.Y-2020-21 under 15th Finance Commission towards the Non-million plus cities.

2. As you are aware that an amount of Rs.70.16 Crs is being released every month under Pattana Pragathi i.e., Rs.35.08 Crs being Finance Commission Grant and Rs.35.08 Crs as State Matching Grant duly distributing to ULB as per norms and the same are being

utilized as per the guidelines mentioned in G.O 3rd cited. Hence, 15th FC grants also shall be utilised in accordance with G.O. in the ref. 3rd cited above.

2.1. In this regard, it is to inform that Gol have issued operational guidelines for utilization of 15th FC grant, as per the norms, the funds are allocated in two equal parts as untied grants and tied grants.

i.50% of the allocated amount i.e., Basic Grant shall be utilized as untied amount for location specific needs (except for salary and establishment expenditure) i.e for the works already informed in the G.O. 3rd cited.

ii. Balance 50% of the allocated amount is Tied Grant, to be utilised for two critical services such as 1. Drinking water supply including Rain water harvesting and recycling and 2.Solid waste Management and this amount will be in addition to the funds received from relevant Centrally Sponsored Schemes (CSS) and other similar schemes being implemented by the State.

3. Therefore, the Municipal Commissioners are instructed to utilize 50% of the 15th FC amount released under Pattana Pragathi Head as untied grant towards all the admissible components mentioned in GO 3rd cited as per need and balance 50% of Tied Grants of 15th FC for Components of SWM, Sanitation, Drinking Water supply Incl RWH as provided in the admissible works in the GO 3rd cited above.
