Sub: Mpl Admn Dept-Pattana Pragathi programme-Preparation of two years Advance
Action Plan-Sanction of works by the DLC-Certain instructions issued-Reg.

Ref: G.O.Rt.No.196, MA & UD Dt.13.05.2020

The attention of all the Municipal Commissioner is invited to the reference cited, wherein the Government have issued orders constituting a District Level Committee and also permitted to accord sanctions for the works proposed with Council Resolution under the following admissible components for utilization of State Matching grants and 14th FC grants released under Pattana Pragathi during 2019-20 and 2020-21:

- a. Sanitation (Purchase of vehicles, purchase of PPE, repairs to sanitation vehicles, IEC, Pattana Pragathi Sanitation Drives, Hire charges of JCB for sanitation, de- siltation of drains, DRCCs , Transfer stations etc.)
- b. Development of Nurseries- Greenary Development under Haritha haram
- c. Development of Crematoriums/Vaikuntadhamams
- d. Development of Integrated markets

- e. Development of Parks and Playgrounds, Gyms
- f. Construction/maintenance of Public Toilets
- g. Development of Auto Stands/ Rickshwa stands
- h. Development of Dump site,
- i. Construction & maintenance of MSWM Processing plants and Bio- mining of legacy waste.
- j. Management of Construction & Demolition waste
- k. Construction and maintenance of FSTPs
- l. Development of Street Vending zones/ Shelters for homeless

2. The Provisions of New Municipalities Act, 2019 and Honble Minister MA&UD in review meetings instructed to prepare ULBs 4 year perspective plan for ULB. Further, Government have also released an amount of Rs.1349.73 Crs to (140) Urban Local Bodies with an intention that all the developmental works required in the respective Municipalities are taken up immediately. But, it is noticed that not even 50% of the total funds released have been utilized and the progress of works is very slow in Municipalities.

3. As there would be regular monthly releases to ULBs under Finance Commission grants and also State matching grants hereafter, all the Municipal Commissioners are hereby instructed to prepare a four years advance action plan identifying all the necessary works to be taken up in the Municipalities and take the administrative approval from the Council and thereafter of District Level Committee for two years action plans(ie 200% sanctions over and the above annual action plan) , so that the delays due to administrative process and procurement process can be addressed appropriately to utilize funds as per timelines.

4. Therefore, all the Municipal Commissioners are hereby instructed to follow the above instructions scrupulously and see that the entire Pattana Pragathi grant is utilized immediately.
