In the reference 1st read above, Government have issued orders for delegating the following financial powers to the Municipal Commissioners to incur expenditure for sanction of works / contingent expenditure for a period of (6) months initially in view of COVID-19 and Monsoon related activities, under section 53(3) of the Telangana Municipal Act, 2019, subject to said monthly expenditure of Municipal Council/ Municipal Corporations shall be placed before the Council, when council is convened, for information and the Municipal Commissioners shall follow the rules and procedure while incurring the above expenditure and extended the said financial powers to the Municipal Commissioners upto March 2021 vide G.O. 2nd read above :

H-JD

(i)	All Municipal Councils	Rs.5,00,000/- per month.
(ii)	All Municipal Corporations	Rs.20,00,000/- per month.

In the circumstances reported by the Commissioner & Director of Municipal Administration in the reference 3rd read above and keeping in view of the prevailing situation of COVID-19 pandemic in the State, Government hereby extends the financial powers to the Municipal Commissioners mentioned at Para.1, up to September, 2021.
- 3. The Director of Municipal Administration, Hyderabad shall take necessary action accordingly.
