ORDER :-

Where-as, in the G.O.3rd read above, the Government have issued the Preliminary notification for amending the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Office Holders and Servants Service Rules, 2000 for amending the method of appointment to the post of Senior Assistant by promotion from Typist / Steno Typist and prescribing ratio between Junior Assistants and Typists / Steno Typist for promotion as 1:1 to the post of Senior Assistant;

2. And whereas, in the letter 4th read above, certain Junior Assistants and Typists working in temples have filed objections and in their objections, the Typists and Junior Assistants have requested for deletion of 1:1 ratio between Junior Assistant and Typist / Steno Typist for promotion to the post of Senior Assistant as prescribed in the note to the preliminary notification issued in G.O.Ms.No. 318, Revenue (Endts.I) Department, Dt. 15.5.2012 and to include the promotion of Typist / Steno Typist and Junior Assistant to the category of Senior Assistant as per seniority;

3. And whereas, in the letter 5th read above, the Commissioner of Endowments Department recommended that the request of Typists and Junior Assistants is genuine;

4. Now therefore, the Government after careful examination, have decided to issue final Notification in the matter;

5. Accordingly, the following notification will be published in an extraordinary issue of the Andhra Pradesh Gazette Dated **20.03. 2013**.

FINAL NOTIFICATION

In exercise of the powers conferred by sub-section (4) of section 35 read with section 153 of the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Act, 1987 (Andhra Pradesh Act No.30 of 1987), the Government of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Office Holders and Servants Service Rules, 2000 issued in G.O.Ms.No.888, Revenue (Endts-I) Department, Dated 08-12-2000 and the same having been previously issued in the G.O.Ms.No.318, Revenue (Endts-I) Dept, Dated: 15-05-2012 and published in the Rules supplement to part-I, Extraordinary issue of the Andhra Pradesh Gazette No.10, dated 15th May, 2012 as required under sub-section (1) of section 153 of the said Act.

AMENDMENTS

In Annexure-III of the said Rules, under the heading Class-I Ministerial Branch:-

- (1) In column (3), against Category-3, Senior Assistant, the existing entry 2 shall be re-numbered as entry 3.
- (2) In columns (3) and (4) against Category-3, Senior Assistant, after the existing entry 1, the following shall be inserted, namely:-

- (3) The following note shall be added to category-3 Senior Assistant, namely:-

“Note:-The promotion of Typist / Steno Typist and Junior Assistant shall be as per the inter-se-seniority fixed among these categories”.
