FINAL NOTIFICATION

In exercise of the powers conferred by sub-section (4) of Section 35 read with Section 153 of the Andhra Pradesh Charitable and Hindu Religious institutions and Endowments Act, 1987 (Andhra Pradesh Act No.30 of 1987), the Government of Andhra Pradesh hereby make the following Amendments to the Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Office Holders and Servants Service Rules, 2000 issued in the G.O.Ms.No.888, Revenue (Endts-I) Department, Dated 08-12-2000 and the same having been previously issued in the G.O.Ms.No.1408, Revenue (Endts-I) Department, Dated: 08-12-2010 and published in the Rules supplement to part-I, Extraordinary of the Andhra Pradesh Gazette No.56, dated 9th December, 2010 as required under sub-section (1) of section 153 of the Act.

AMENDMENTS

In the said rules, in the Annexure-III, under the heading Class – I, Ministerial Branch:-

- 1) In column (3) against category 4, Junior Assistants, the existing entry 2 shall be re-numbered as entry 3.
- 2) In columns (3) and (4) against category 4, after the existing entry 1 and entry respectively, the following shall be inserted, namely:-

“ (2) By Promotion from Record Assistant	Must have passed intermediate or equivalent examination “

- 3) The following note shall be added to category 4, namely:-
“NOTE: The ratio between Direct Recruitment and promotion shall be 1:1.”
