ORDER:-

According to Rule 3 of Andhra Pradesh Charitable and Hindu Religious Institutions and Endowments Subordinate Service Rules issued in the G.O. 1st read above, the method of appointment of the post of Executive Officer Grade-II is by way of transfer from the category of Senior Assistant of A.P. Ministerial Service in the Endowments Department and Senior Assistants working in the institutions published under Section 6 (a), (b), (c) and (d) of the Act other than Regional Joint Commissioner and Deputy Commissioner cadre institutions.

The Commissioner, Endowments Department, Hyderabad in his letter second read above has stated that the cadre strength of Executive Officer Grade-II is 197 out of which 94 Executive Officers Grade-II are working, and the balance 103 posts are vacant for a long time. Out of 103 vacant posts of Executive Officer Grade-II, 21 posts are earmarked to departmental Senior Assistants and 81 posts are earmarked to Executive Officer Grade-III for promotion to the post of Executive Officer Grade-II. 1 (one) post of which is earmarked to Temple Senior Assistant is also vacant. But, no departmental Senior Assistants has given option for appointment by transfer of service as Executive Officer Grade-II. Hence, all the 21 posts are lying vacant for a long time. Due to this, number of posts of Executive Officer Grade-II earmarked for departmental Senior Assistants are being kept in additional charge which is becoming difficult for day to day administration of the institutions. He has also stated that, number of Senior Assistants working in the Institutions who are qualified have been put into longer service and they are being waiting for promotions. He has further stated that the Temple Employees Association has also represented to make appointment by way of transfer from feeder category of temple employees i.e. Senior Assistants of the Institutions into the vacancies meant for the feeder category of departmental Senior Assistants. As there is no objection from the departmental Senior Assistants, not only the vacant posts will be filled, but also an opportunity could be given to the temple employees who put in longer service in the temples. Thus, it is also convenience for administration of the Institutions by the Endowments Department.

He has therefore requested the Government to accord permission to fill up the vacancies of Executive Officers Grade-II which are earmarked to Departmental Senior Assistants, with the feeder category of temple employees.
