#### ORDER;

Certain Junior Assistants working in various temples in Zone-II who have crossed 45 years of age have requested for exemption from passing of tests prescribed in the Special rules for the purpose of promotion to the next higher category/appointment by transfer by amending the rules issued in G.O.Ms.No.262, Revenue (Endts.I) Department, dated 20.05.2002.

- 2. Government after careful consideration have decided to amend the said rules. Accordingly, a preliminary notification was issued in the G.O. 4<sup>th</sup> read above and the same was published in the Extraordinary issue of the Andhra Pradesh Gazette dated: 18.12.2007.
- 3. In response to the above preliminary notification, the Telengana Endowments Department Temple Employees Association and certain other employees working the Endowments Department have submitted their objections in the reference 5<sup>th</sup> read above, in regard to the amendment of rule 3 of the said rules as proposed.
- 4. Government after careful consideration of the above objections, have decided to accept the objections and amend the said rules.

The Provisions of Adhoc rules issued in G.O.Ms.No.225, General Administration (Ser.C) Department, dated:18.05.1999 under the proviso to article 309 of the Constitution of India as amended from time to time shall be applicable".
