ORDER:-

In the references 1^{st} and 2^{nd} read above, Rs.30.00 Crore as grant towards Capacity Building for Disaster Response (CBDR) 2010-11 to 2014-15, @ Rs.6.00 crores per annum, as per the recommendations of the 13th Finance Commission, was released in the erstwhile State of Andhra Pradesh. Out of this Rs.12 Crore (for 2010-11 & 2011-12) was released and also utilized.

- 2. In the reference 3rd read above, it was informed that in the 13th Finance Commission Grant for Capacity Building activities for 2014-15 residual grants have been apportioned to Telangana, and share of Telangana works out to Rs. 7.31 Crores
- 3. In the reference 4th read above, the Director General, State Disaster Response and Fire Service, Telangana requested to issue orders for constituting State Disaster Response Force (SDRF) and allocate the balance funds of Rs.748.59 lakhs towards the training and Capacity Building of State Disaster Response Force (SDRF) personnel and procurement of Search & Rescue equipment for Six teams at Hyderabad, Cyberabad, Warangal, Karimnagar, Nizamabad and Bhadrachalam in Khammam District from the funds of Grant-in-Aid recommended by the Thirteenth Finance Commission (FC-XIII) for Capacity Building for Disaster Response and/ or State Disaster Response Funds.
- 4. In the reference 6th read above, Govt., sanctioned an amount Rs.2,43,67,000/-(Rupees Two Crores Forty Three Lakhs Sixty Seven Thousands only) to the Director General, State Disaster Response and Fire Services, Telangana as 1st installment [3rd installment as per 13th Finance Commission Grant] towards the training and Capacity Building of State Disaster Response Force (SDRF) personnel and procurement of Search & Rescue equipment for Six teams at Hyderabad, Cyberabad, Warangal, Karimnagar, Nizamabad and Bhadrachalam in Khammam District from the funds of Grant-in-Aid recommended by the Thirteenth Finance Commission (FC-XIII) for Capacity Building for Disaster Response.
- 5. In the reference 7th read above, the Budget Release Order (BRO) issued on 17.03.2015 for Rs.2,43,70,000/- lapsed due to end of Financial Year, consequently administrative sanction accorded vide reference 8th read above also lapsed. Consequently, in the reference 9th read above, another Budget Release Order (BRO) was issued to the Commissioner for relief, HOD for an amount of Rs.2,43,70,000/- (Rupees Two Crores Forty Three lakhs and Seventy Thousand only) Non-plan from the BE provision 2015-16 revalidating towards 'Capacity Building for Disaster Response (CBDR)' as 4th installment under 13th Finance Commission Grants in relaxation of TCO and quarterly regulations pending provision of funds by obtaining supplementary grants at appropriate time.

- 6. Government after careful consideration of the matter, hereby sanction a sum of Rs.2,43,70,000/- (Rupees Two Crores Forty Three Lakhs and Seventy Thousand only) to the Director General, State Disaster Response and Fire Services, Telangana as 2nd installment [4th installment as per 13th Finance Commission Grant] towards the training and Capacity Building of State Disaster Response Force (SDRF) personnel and procurement of Search & Rescue equipment for Six teams at Hyderabad, Cyberabad, Warangal, Karimnagar, Nizamabad and Bhadrachalam in Khammam District from the funds of Grant-in-Aid recommended by the Thirteenth Finance Commission (FC-XIII) for Capacity Building for Disaster Response.
