1. From the Prl. Secy., to Govt., PR&RD Relief Department, D.O.Lr.No.3741/R1f.111/96, Dt.16.3.1996 addressed to the Coastal District Collectors including Khammam and Hyderabad.
2. From the District Collector, Khammam, Rc.No.D2/218/2015, dt: 21.02.2015.

**ORDER:**

In the reference 1<sup>st</sup> read above, in erstwhile State of Andhra Pradesh instructions were issued to the coastal District Collectors including Khammam and Hyderabad to form the District "Ham Radio Clubs" as per the following pattern:

District Collector	President
Joint Collector	Vice-President
DRO	Treasurer
Secretary	Ham (he/she)
Joint Secretary	Ham (he/she)

The District Collectors were also directed to utilize the services of employees of the National Institute of Amateur Radio (NIAR).

2. Accordingly, the District Collectors have registered the Ham Radio Clubs in their Districts. They have been utilizing the services of the Ham Radio personnel at the time of Natural Calamities as well as in Revenue Communication network etc. during normal times also throughout the year. Necessary Budget is being released on yearly basis for payment of honorarium to the HAM personnel based on the proposals received from the District Collectors.

3. In the reference 2<sup>nd</sup> read above, the District Collector, Khammam has requested the Government to continue Ham Radio Club and to release necessary Grants-in-Aid for payment of honorarium payable to Smt P.Rajitha Kishore, Ham Radio Secretary, District Collector, Khammam for the period of 2014 -2015 (w.e.f. 14.02.2015) and for the financial year 2015-16.

4. Government, after careful consideration of the proposal received from the District Collector, Khammam hereby accord sanction for continuance of Ham Radio Club, Khammam and also accord sanction for an amount of Rs.1,47,461 (Rupees One Lakh Forty Seven Thousand and Four Hundred and Sixty One Only) for payment of honorarium to Smt. P. Rajitha Kishore, the Ham personnel working in District Ham Radio Club, District Collectorate, Khammam. The payment shall be made to the Ham Radio Operator as detailed below:

5. The expenditure sanctioned in para ( 4 ) above shall be debited to the following head of account:

“MH – 2245 – Relief on account of Natural Calamities – S.M.H. 80- General M.H.-102- Management of Natural Disaster Contingency Plans in disaster prone areas – SH(04)- Disaster Management -280 – Professional Services – 284 – Other Payments.”

6. The expenditure sanctioned above is exempted from Treasury Control Orders and Quarterly Regulation orders.

7. The District Collector, Khammam is hereby authorized to draw the above sanctioned amount and utilize the services of Ham Radio Club for communication purposes at the time of Natural Calamities and also in Revenue network regularly and incur the expenditure for the purpose for which it is sanctioned.

8. The District Collector, Khammam shall verify the attendance particulars of the Ham Radio Operator before payment of Honorarium to her and if any unauthorized absence, the amount to that extent may be deducted and remitted to the above Head of Account and particulars of such remittances may be intimated to Government.

9. The District Collector, Khammam shall send Utilization Certificates duly verified by the audit authorities to the Revenue (Disaster Management - Accounts) Department. The District Collector is also requested to see that duties and responsibilities are followed.

10. This order issues with the concurrence of Finance (Exp. Rev.) Dept. vide their U.O. No.6150/281/EBS.VII/15 dated 15.05.2015.
