In the reference 3rd read above, the Finance (EBS.VII) Department has issued Budget Release Order for an amount of Rs.16,38,00,000/- (Rupees Sixteen Crores and Thirty Eight Lakhs only) Non- plan as additional funds in relaxation of Treasury Control and Quarterly Regulation Orders, pending provision of funds by way of obtaining Supplementary Grants during the financial year 2015- 16 towards meeting the expenditure to mitigate the drinking water problems in 67 ULBs of Telangana State during the ensuing Summer, 2015.
