## **ORDER:**

In the reference  $2^{nd}$  read above, the Commissioner of Horticulture, Telangana, Hyderabad has stated that in the reference  $1^{st}$  read above Govt., of AP released an amount of Rs.39,78,04,000/- (for combined State) from SDRF towards input subsidy to the affected small/marginal and other farmers whose Horticulture crops were damaged more than 50% due to heavy rains and hailstorms occurred during 2010-2013.

- 2. In the reference 2<sup>nd</sup> read above, the Commissioner of Horticulture, Hyderabad has stated that the amount sanctioned vide G.O.Rt. No.146, Rev (DM-I) Dept, Dt.14.05.2014 could not be utilized due to lapse of the Financial Year. Hence, he has requested to issue revised BRO and administrative sanction orders for an amount of **Rs. 2171.26** lakhs for release of funds for the financial year 2014-15, pertains to the Telangana districts input subsidy to the affected farmers whose horticulture crops were damaged due to Hailstorms & Heavy Rains occurred during 2010 2013, as Rs.616.19 lakhs was drawn by Medak, Mahabubnagar and Ranga Reddy Districts out of the total of Rs.2787.45 lakhs sanctioned.
- 3. Details of District-wise input subsidy are given below:

- 4. The Finance (EBS.VII) Dept., in the reference 3<sup>rd</sup> read above, issued Budget Release Order (BRO) for an amount of Rs.21,71,26,000/-(Rupees Twenty one Crores Seventy One Lakh and Twenty Six Thousand Only) as additional funds towards input subsidy for Horticulture crop damaged due to Hailstorms and Heavy Rains occurred from the years 2010-2013 in relaxation of Treasury Control and Quarterly Regulation Orders pending provision of funds by way of obtaining supplementary grants during F/Y 2015-16.
- 5. After careful examination of the matter, Government hereby release an amount of Rs.21,71,26,000/- (Rupees Twenty one Crores Seventy One Lakh and Twenty Six Thousand Only) from State Disaster Response Fund (SDRF) to the Commissioner of Horticulture, Hyderabad, towards input subsidy as per State norms to the affected Small/ Marginal and Other farmers, whose Horticulture crops were damaged more than 50% due to Hailstorms and Heavy Rains occurred during the years 2010-2013, subject to conditions that:
  - i. that payment of input subsidy will be done directly to the bank accounts of farmers which should be Aadhar linked as far as possible.
  - ii. Payments shall be made within a period of 90 days from the date of release of funds.
  - iii. Every farmer will be entitled for input subsidy for only one Disaster for the same agricultural season.
- 6. The expenditure sanctioned in para (5) above shall be debited to the head of Account:

MJH - 2245 - Relief on account of Natural Calamites

SMJH - 02 - Floods, Cyclones etc.,

M.H 101 - Gratuitous Relief

SH (09) - Supply of Seeds, Fertilizers and Agricultural

**Implements** 

310 - Grants - in - Aid

312 - Other Grants - in- Aid

- 7. The Commissioner of Horticulture, Telangana, Hyderabad, is authorized to draw the amount sanctioned in para (5) above and arrange to disburse/distribute the same to the affected farmers through transfer to bank account by way of cheques/ECS and utilize the funds for the purpose for which it is sanctioned.
- 8. The Commissioner of Horticulture, Hyderabad, is directed to furnish the District-wise distribution particulars to the Government as well as Director of State Audit, TS Hyderabad urgently.

- 9. The Commissioner of Horticulture, Hyderabad, is also directed to furnish the Consolidated Utilization Certificates for the amount sanctioned now duly verified by the Telangana State Audit Authorities. The Commissioner & Director of Horticulture, Hyderabad, shall remit back the unspent balances, if any, forthwith to Government Account.
- 10. The expenditure mentioned in para (5) above is sanctioned in relaxation of Treasury Control and quarterly regulation Orders pending obtaining supplementary grants during 2014-15.
- 11. This order issues with the concurrence of the Finance (EBS.VII) Dept., vide their Fin. U.O.No.11221/467/EBS.VII/Rev/2015, Dt.09.09.2015.
