**ORDER:**

In the reference 1<sup>st</sup> read above, the Commissioner and Director of Agriculture, Telangana Hyderabad has informed through the APC & Principal Secretary to Govt, Agriculture & Cooperation Dept., that the District Collector, Warangal has submitted the final enumeration reports with beneficiary lists along with Bank account numbers of the farmers whose crops were damaged due to gale/Heavy Rains during April 2012 in Bachannapet Mandal of Warangal District after a lapse of 2 ½ years.

2. The Commissioner and Director of Agriculture, Telangana, Hyderabad has informed through the APC & Principal Secretary to Govt, Agriculture & Cooperation Dept., that, Govt in G.O.Rt.No.7, Revenue (DM) Department dated:12.08.2014 have released an amount of Rs.356.90 lakhs towards input subsidy to the 14,785 farmers of Warangal District whose crops were damaged due to Hail storms occurred during April, 2012 and May, 2012 in which the Bachannapet Mandal was not included and requested the Govt., for releases of an amount of Rs.53.71 lakhs towards input subsidy to the affected Small and Marginal farmers of Bachannapet Mandal of Warangal District for gale/Heavy rains occurred during April, 2012 and the details of the input subsidy requirement is furnished below:

3. The Finance (EBS.VII) Dept., in the reference 2<sup>nd</sup> read above, issued Budget Release Order (BRO) for an amount of **Rs.53.71** lakhs (Rupees fifty three lakhs and seventy one thousand Only) as additional funds towards input subsidy to the affected farmers whose Agriculture crops were damaged due to Gale/Heavy rains occurred during April 2012 in Bachannapet Mandal, Warangal District.

4. After careful examination of the matter, Government hereby release an amount of **Rs.53.71** lakhs (Rupees fifty three lakhs and seventy one thousand Only) from State Disaster Response Fund (SDRF) to the Director of Agriculture, Telangana, Hyderabad towards input subsidy to the affected Small/ Marginal and Other farmers as per norms, whose agriculture crops were damaged due to Gale/Heavy rains occurred during April 2012 in Bachannapet Mandal, Warangal District subject to conditions that:

- i. That payment of input subsidy will be done directly to the bank accounts of farmers which should be Aadhar linked as far as possible.

- ii. Payments shall be made within a period of 90 days from the date of release of funds.
  - iii. Every farmer will be entitled for input subsidy for only one Disaster for the same agricultural season.
5. The expenditure sanctioned in para (4) above shall be debited to the head of Account:

6. The Director of Agriculture, Telangana, Hyderabad, is authorized to draw the amount sanctioned in para (4) above and arrange to disburse/distribute the same to the affected farmers through transfer to bank account by way of cheques/ECS and utilize the funds for the purpose for which it is sanctioned.
7. The District Collector should ensure that the disbursement shall be made only under strict supervision so that only genuine beneficiaries get the input subsidy.
8. The District Collector should ensure of that Model Code Conduct of Election Commission of India is not in force before undertaking disbursement.
9. The Director of Agriculture, Telangana, Hyderabad, is directed to furnish the distribution particulars to the Government as well as Director of State Audit, TS Hyderabad urgently.
10. The Director of Agriculture, Telangana, Hyderabad is also directed to furnish the Consolidated Utilization Certificates for the amount sanctioned now duly verified by the Telangana State Audit Authorities. The Director of Agriculture, Telangana, Hyderabad shall remit back the unspent balances, if any, forthwith to Government Account.
11. The expenditure mentioned in para (4) above is sanctioned in relaxation of Treasury Control and quarterly regulation Orders pending obtaining supplementary grants during 2015-16.
12. This order issues with the concurrence of the Finance (EBS.VII) Dept., vide their Fin.U.O.No.0627/576/EBS-VII/Rev/2015, dt.08.12.2015.
