ORDER:

In the reference first read above, the Director of Animal Husbandry, Telangana, Hyderabad has requested an amount of Rs.162 Lakhs for rehabilitation of (6000) animals for 90 days in Mahabubnagar District, in view of the existing drought conditions in the District. The estimated budget requirement for providing dry fodder @4 kg per animal @ Rs.7/- per kg and Drinking water for 90 days is as follows:

- In the reference 2nd read above, the Finance (EBS.VII) 2. Department has issued Budget Release Order for an amount of Rs.1,08,00,000/- (Rupees One Crore Eight Lakh only) Non-plan as additional funds in relaxation of Treasury Control and Quarterly Regulation Orders by way of obtaining Supplementary Grants during the financial year 2016-17 to meet the expenditure towards rehabilitation of 6000 animals in Mahabubnagar District as per the SDRF norms.
- Government after careful examination of the matter, hereby release an amount of Rs.1,08,00,000/- (Rupees One Crore Eight Lakh only) from State Disaster Response Fund [SDRF] to the Director of Animal Husbandry, Hyderabad for providing dry fodder @4 kg per animal @ Rs.7/- per kg and Drinking water for 6000 animals for 60 days in Mahabubnagar District, as per existing SDRF norms.
