## <u>ORDER :</u>

In the reference 1<sup>st</sup> read above, the Ministry of Home Affairs (Disaster Management Division), Government of India, New Delhi have issued the 'Guidelines on Constitution and Administration of the State Disaster Response Fund (SDRF) for the period of 2015-20'. As per these Guidelines, "Five percent (5%) of the annual allocation of SDRF may be kept for Capacity Building Activities by the States". These activities are as under:-

- a) Setting up/Strengthening of Emergency Operation Centres (EOCs) in the State.
- b) Training/Capacity Building of Stakeholders and functionaries in the State.
- c) Supporting disaster management centres of State ATIs and other institutions.
- d) Preparation of Disaster Management Plans based on Hazards, Risk and Vulnerability Analysis.

2. In the reference 2<sup>nd</sup> read above, the Chief Executive Officer, TSI PR& RD, Hyderabad has proposed for taking up Capacity Building activity in the area of Disaster Management for Telangana State for the year 2016-17. Further, he requested the State Government to release an amount of Rs.15,00,000/- (Rupees Fifteen Lakhs Only) as estimated towards the cost of training programs.

3. In the reference 3<sup>rd</sup> read above, the State Executive Committee in its meeting held on 21–06–2016 approved the various proposals of Capacity Building for Disaster Response (CBDR) activities in the State for the year 2016-17 of the 14<sup>th</sup> Finance Commission and authorized expenditure for 5% State Disaster Response Fund (SDRF) for Capacity Building for Disaster Response (CBDR) activities of various items. The State Executive Committee (SEC) also approved the proposal contains allotment of funds to Telangana State Institute of PR & RD, Hyderabad.

4. In the reference 4<sup>th</sup> read above, the Finance (FC) Department has issued Budget Release Order (BRO) for an amount of Rs.15,00,000/- (Rupees Fifteen Lakhs Only) to the Commissioner for Disaster Management, Hyderabad, towards Capacity Building Activities under 14<sup>th</sup> Finance Commission Grants.

5. Government after careful consideration of the proposals of the Chief Executive Officer, TSI PR & RD, Hyderabad hereby sanction and release a sum of Rs.15,00,000/- (Rupees Fifteen Lakhs Only) towards the proposed training programs.

8. The expenditure now sanctioned and released shall be utilised for the purpose for which it is sanctioned, the Chief Executive Officer, TSI PR & RD, Hyderabad, shall submit audited utilisation certificate in this regard immediately.
