ORDER:

The Director of Agriculture, Hyderabad vide reference 1st read above, has forwarded the proposal of the District Collector, Ranga Reddy District and stated that Sri. M. Anjireddy, has filed representation stating that fire accident occurred on 14.02.2015 in Sy.No.16 to an extent of Ac.9.22gts in Mominpet Village & Mandal. Due to Fire accident the maize crop covering an area of Ac.5-00 **(two (02) hectares only)** has been brunt in fire. Therefore the Collector, Ranga Reddy District has requested the Director of Agriculture, Hyderabad to sanction relief assistance in the matter as per rules in vogue.

2. The Government vide reference 2nd read above has issued orders for adopting the revised norms of assistance from State Disaster Response Fund (SDRF)/National Disaster Response Fund (NDRF) w.e.f., 01.04.2015 issued by the Government of India, the input subsidy for Maize @ Rs.8,333/- per ha only.

3. The Government, after careful examination, have decided to release an amount of Rs.16,666 (Rupees Sixteen thousand Six hundred sixty six only) from State Disaster Response Fund (SDRF) towards sanction of relief in respect of Maize crop gutted in fire accident @ Rs.8,333/- ha for 2 Ha which comes to Rs.16,666/- (Rs.8,333/- X 2 ha. =16,666/-).The expenditure accorded in para (5) above shall be debited to the following Head of Account: 2245-80-102-25-04-310-312.

4. The Collector & District Magistrate, Rangareddy is requested to take further necessary action in the matter.
