**ORDER:**

In the reference 1<sup>st</sup> read above, Government have released an amount of Rs.7.56 crores to settle 1512 Apathbandhu cases pertaining to policy year 2007-2008 to 2016-2017.

2. In the reference 2<sup>nd</sup> read above, the District Collectors were requested to furnish pending Apathbandhu proposals pertaining to the policy year 2017-2018. In response to Govt., Memo dated: 20.11.2017 the District collectors have furnished the pending Apathbandhu proposals for 2010 to 2018.

3. In the reference 3<sup>rd</sup> read above, Government have decided to continue the Apathbandhu Scheme for the policy year 2017-2018.

4. In the reference 4<sup>th</sup> read above, Finance (EBS.VII) Dept., have issued Budget Release Orders for an amount of Rs. 2.89 crores (Rs. Two Crores Eighty Nine Lakhs Only) Scheme from the BE provision 2018-19 towards meeting the expenditure to settle pending eligible Apathbandhu Cases for 2010-2011 to 2017-2018 respectively.

5. After careful examination of the matter, Government hereby release an amount of 2.89 crores (Rs. Two Crores Eighty Nine Lakhs Only) to all the District Collectors in the State as shown below towards meeting the expenditure to settle Apathbandhu eligible Cases pertaining to financial year 2010-2011 to 2017-2018 for payment of Rs.50,000/- for each death as ex-gratia as per Apathbandhu Scheme guidelines.

6. The expenditure accorded in para (5) above shall be debited to the following Head of Account:-

7. All the District Collectors in the State are authorized to draw the amount sanctioned in para (5) above and arrange for disbursement of the same to the BPL families, in case of accidental death in the family through transfer to bank account of the concerned by way of RTGS/ EFT (Real Time Gross Settlement/ Electronic Funds Transfer) and utilize the funds for the purpose for which it is sanctioned, as per Apathbandhu Scheme guidelines.

8. The District Collectors in the State are directed to furnish the distribution particulars to the Government as well as the Director of State Audit, Hyderabad urgently.

9. The District Collectors in the State are also directed to furnish the Consolidated Utilization Certificates for the amounts sanctioned now duly verified by the State Audit Authorities. The District Collectors in the State shall remit the unspent balances, if any, forthwith to Government Account.
