ORDER:

In the G.O. 1st read above, Government have issued orders for notification of Thunderbolt under the provisions of Special Disasters, within the local context of the State, as State Specific Disaster and fixed the ex-gratia for an amount of Rs.6.00 lakhs to the families of the deceased persons due to thunder bolt.

2. In the reference 2nd read above, the Collector & District Magistrate, Jogulamba Gadwal has submitted the proposals to the Government for sanction of Ex-gratia in respect of Late Sri Kurva Gopal & Smt. K.Manikyamma, Guddemdoddi(v), Dharur(M), who were died due to fallen of Thunderbolt on 17.09.2018, in agriculture field nearby their village and stated that the proposals are scrutinized and satisfied with the report of Three Men Committee. The Collector & District Magistrate, Jogulamba Gadwal has recommended to the Government for sanction of Ex-gratia for an amount of Rs.6.00 lakhs to the minor children's of the deceased couple, who were died on 17.09.2018, due to Thunderbolt, under the provision of Special Disaster, as per orders issued in the G.O. 1st read above.

3. In the G.O. 3rd read above, the Finance (EBS.VII) Department have issued Budget Release Order (BRO) for an amount of Rs.6.00 lakhs (Rupees Six Lakhs only) towards meeting the expenditure for payment of Ex-gratia to the deceased family of Late Sri Kurva Gopal & Smt. K.Manikyamma, Guddemdoddi(v), Dharur(M), Jogulamba Gadwal District who were died due to thunder bolt on 17.09.2018.

4. After careful examination of the matter, Government hereby sanction an amount of Rs.6.00 lakhs (Rupees Six Lakhs only) towards payment of Ex-gratia, to the deceased family of Late Sri Kurva Gopal & Smt. K.Manikayamma, Guddemdoddi(v), Dharur(M), Jogulamba Gadwal District, who were died due to thunder bolt on 17.09.2018.

5. The expenditure sanctioned in para (4) above shall be debited to the Head of Account:

MJH	– 2245 – Relief on account of Natural Calamities
SMJH	– 80 -General
M.H	- 800 – Other expenditure
GSH	- 25 – State Sector Schemes
SH	- 13 – Payment of Ex-gratia to deceased persons due to Thunderbolt
DH	- 310 – Grants – in – Aid
SDH	- 312 – Other Grants – in– Aid

6. The Collector & District Magistrate, Jogulamba Gadwal District is authorized to draw the amount sanctioned in para (4) above and disburse the same to the deceased family through transfer to bank account by way of ECS and utilize the funds for the purpose for which it is sanctioned. And also directed to furnish the Utilization Certificate, duly verified by the State Audit Authorities.
