ORDER:

In the reference 1st read above, the Commissioner of Agriculture, Telangana, Hyderabad has furnished the final enumeration agricultural crop damage reports due to Heavy rains occurred from 11th to 23rd August, 2018 in various Districts in the State i.e. Mancherial, Badradri Kothagudem, Adilabad, Jayashankar Bhupalapally, Nirmal, Asifabad, Peddapalli, Suryapet, Jagtial, Khammam, Kamareddy and Nizamabad and requested the Government to release an amount of Rs.2234.15 lakhs towards input subsidy to the farmers whose crops were damaged.

2. District-wise requirement of input subsidy, number of farmers and Area pertaining to Heavy Rains occurred from 11th to 23rd August, 2018 as detailed below:

3. In the G.O. 2nd read above, Finance (EBS.VII) Department have issued Budget Release Order (BRO) for an amount of Rs.2234.15 lakhs (Rupees Twenty Two Crores Thirty Four lakhs and Fifteen thousand Only) as additional funds towards meeting expenditure for input subsidy to the farmers whose crops were damaged due to Heavy rains occurred on 11th to 23rd August, 2018 in various Districts in the state, in relaxation of quarterly regulation and Treasury Control Orders by way obtaining supplementary grants during the FY 2019-20.

4. After careful examination of the matter, Government hereby release an amount of Rs.2234.15 lakhs (Rupees Twenty Two Crores Thirty Four lakhs and Fifteen thousand Only) from State Disaster Response Fund (SDRF) to the Commissioner of Agriculture, Telangana, Hyderabad, towards input subsidy to the farmers whose agricultural crops were damaged due to heavy rains occurred from 11th to 23rd August, 2018, in various Districts in the State i.e. Mancherial, Badradri Kothagudem, Adilabad, Jayashankar Bhupalapally, Nirmal, Asifabad, Peddapalli, Suryapet, Jagtial, Khammam, Kamareddy and Nizamabad subject to conditions that :

- i. that payment of input subsidy will be done directly to the bank accounts of farmers which should be Aadhar linked as far as possible.
- ii. Payments shall be made within a period of 90 days from the date of release of funds.
- iii. Every farmer will be entitled for input subsidy for only one Disaster for the same agricultural season.

5. The expenditure sanctioned in para (4) above shall be debited to the Head of Account:

6. The Commissioner of Agriculture, Telangana, Hyderabad, is authorized to draw the amount sanctioned in para (4) above and arrange to disburse/distribute the same to the affected farmers through transfer to bank account by way of ECS and utilize the funds for the purpose for which it is sanctioned.

7. The District Collectors should ensure that the disbursement shall be made only under strict supervision so that only genuine beneficiaries get the input subsidy.

8. The Director of Agriculture, Telangana, Hyderabad, is directed to furnish the District-wise distribution particulars to the Government as well as Director of State Audit, Telangana, Hyderabad urgently.

9. The Commissioner of Agriculture, Telangana, Hyderabad is also directed to furnish the Consolidated Utilization Certificates for the amount sanctioned now duly verified by the Telangana State Audit Authorities and shall remit back the unspent balances, if any, forthwith to Government Account.
