# **ORDER:**

In the G.O. 1<sup>st</sup> read above, Government have issued orders for notification of Thunderbolt under the provisions of Special Disasters, within the local context of the State, as State Specific Disaster and fixed the ex-gratia for an amount of Rs.6.00 lakhs to the families of the deceased persons due to thunder bolt.

2. In the reference  $2^{nd}$  read above, the Collector & District Magistrate, Kumaram Bheem Asifabad has submitted the proposals to the Government for sanction of ex-gratia in respect of Late Sri Thumram Yadav Rao, S/o Namdev, Gudamamada(v), Jainoor(M), aged about (24) years, who was died due to striking of Thunderbolt on 14.04.2019. The proposals are examined and the Three men Committee has also opined that the deceased person was died due to thunderbolt. The Collector & District Magistrate, Kumaram Bheem Asifabad has recommended to the Government for sanction of ex-gratia for an amount of Rs.6.00 lakhs to the family of the deceased person under the provision of Special Disaster, as per orders issued in the G.O. 1<sup>st</sup> read above.

3. In the G.O. 3<sup>rd</sup> read above, the Finance (EBS.VII) Department have issued Budget Release Order (BRO) for an amount of Rs.6.00 lakhs (Rupees Six Lakhs only) towards meeting the expenditure for payment of ex-gratia to the family of Late Sri Thumram Yadav Rao, S/o Namdev, Gudamamada(v), Jainoor(M), Kumaram Bheem Asifabad District, who died due to Thunderbolt on 14.04.2019.

4. After careful examination of the matter, Government hereby sanction an amount of Rs.6.00 lakhs (Rupees Six Lakhs only) towards payment of ex-gratia, to the family of Late Sri Thumram Yadav Rao, S/o Namdev, Gudamamada(v), Jainoor(M),who died due to Thunderbolt on 14.04.2019.

5. The expenditure sanctioned in para (4) above shall be debited to the Head of Account:

MJH	– 2245 – Relief on account of Natural Calamites
SMJH	– 80 -General
M.H	- 800 – Other expenditure
GSH	- 25 – State Sector Schemes
SH	- 13 – Payment of Ex-gratia to deceased persons due to Thunderbolt
DH	- $310$ – Grants – in – Aid
SDH	- 312 – Other Grants – in– Aid

6. The Collector & District Magistrate, Kumaram Bheem Asifabad District is authorized to draw the amount sanctioned in para (4) above and disburse the same to the deceased family through transfer to bank account by way of ECS and utilize the funds for the purpose for which it is sanctioned. And also directed to furnish the Utilization Certificate, duly verified by the State Audit Authorities.

7. The expenditure mentioned in para (4) above is sanctioned as additional fund in relaxation of Treasury Control and quarterly regulation orders by way of obtaining supplementary estimates during FY 2019-20.
