ORDER:

In the G.O. 1st read above, Government have issued orders for notification of Thunderbolt under the provisions of Special Disasters, within the local context of the State, as State Specific Disaster and fixed the ex-gratia for an amount of Rs.6.00 lakhs to the families of the deceased persons due to thunder bolt.

2. In the reference 2nd read above, the Collector & District Magistrate, Nizamabad has stated that due to unseasonal rains occurred on 22.05.2019, (2) persons namely Sri Gangula Nadipi Linganna, S/o. Bhoomanna and Sri Nakka Narsaiah, S/o, Limbanna, both are resident of Vadiyat(v) of Morthad (M) , were died due to thunderbolt. The proposals are examined and the Three men Committee has also opined that the deceased persons were died due to thunderbolt. The Collector & District Magistrate, Nizamabad has recommended to the Government for sanction of ex-gratia of an amount of Rs.12.00 lakhs to the families of the deceased persons under the provision of Special Disaster, as per orders issued in the G.O. 1st read above.

3. In the G.O. 3rd read above, the Finance (EBS.VII) Department have issued Budget Release Order (BRO) for an amount of Rs.12.00 lakhs (Rupees Twelve Lakhs only) towards meeting the expenditure for payment of ex-gratia of Rs.6.00 lakhs to the family of Late Sri Gangula Nadipi Linganna, S/o. Bhoomanna and Rs.6.00 lakhs to the family of Late Sri Nakka Narsaiah, S/o, Limbanna, Vadiyat(v) of Morthad (M), Nizamabad District, who were died due to Thunderbolt on 22.05.2019.

4. In pursuance of the orders issued in the G.O. 3rd read above, Government hereby sanction an amount of Rs.12.00 lakhs (Rupees Twelve Lakhs only) towards meeting the expenditure for payment of ex-gratia of Rs.6.00 lakhs to the family of Late Sri Gangula Nadipi Linganna, S/o. Bhoomanna and Rs.6.00 lakhs to the family of Late Sri Nakka Narsaiah, S/o, Limbanna, Vadiyat(v) of Morthad (M), Nizamabad District, who were died due to Thunderbolt on 22.05.2019.

5. The expenditure sanctioned in para (4) above shall be debited to the Head of Account:

The Collector & District Magistrate, Nizamabad is authorized to draw the amount sanctioned in para (4) above and disburse the same to the deceased families through transfer to bank account by way of ECS and utilize the funds for the purpose for which it is sanctioned. And also directed to furnish the Utilization Certificate, duly verified by the State Audit Authorities.

7. The expenditure mentioned in para (4) above is sanctioned as additional fund in relaxation of Treasury Control and quarterly regulation orders by way of obtaining supplementary estimates during FY 2019-20.
