**ORDER:**

In the G.O. 1<sup>st</sup> read above, Government have issued orders for notification of Thunderbolt under the provisions of Special Disasters, within the local context of the State, as State Specific Disaster and fixed the ex-gratia for an amount of Rs.6.00 lakhs to the families of the deceased persons due to thunder bolt.

2. In the reference 2<sup>nd</sup> read above, the Collector & District Magistrate, Mahabubabad has stated that the Revenue Divisional Officer, Thorur has submitted proposals for sanction of Ex gratia to the family of Sri Bhukya Ramulu, S/o Roopla , Yerabelligudem (v), Nellikudur(M), who was died due to thunderbolt on 17.09.2018, nearby their agriculture lands. The proposals are examined and the Three men Committee has also opined that the deceased person was died due to thunderbolt. The Collector & District Magistrate, Mahabubabad has recommended to the Government for sanction of ex-gratia of an amount of Rs.6.00 lakhs to the family of the deceased person under the provision of Special Disaster, as per orders issued in the G.O. 1<sup>st</sup> read above.

3. In the G.O. 3<sup>rd</sup> read above, the Finance (EBS.VII) Department have issued Budget Release Order (BRO) for an amount of Rs.6.00 lakhs (Rupees Six Lakhs only) towards meeting the expenditure for payment of ex-gratia to the family of Late Sri Bhukya Ramulu, S/o Roopla, Yerabelligudem (v), Nellikudur(M), Mahabubabad District, who was died due to Thunderbolt on 17.09.2018.

4. In pursuance of the orders issued in the G.O. 3<sup>rd</sup> read above, Government hereby accord sanction for an amount of Rs.6.00 lakhs (Rupees Six Lakhs only) towards payment of ex-gratia, to the family of Late Sri Bhukya Ramulu, S/o Roopla, Yerabelligudem (v), Nellikudur(M), Mahabubabad District, who was died due to Thunderbolt on 17.09.2018.

5. The expenditure sanctioned in para (4) above shall be debited to the Head of Account:

MJH – 2245 – Relief on account of Natural Calamities  
SMJH – 80 – General  
M.H – 800 – Other expenditure  
GSH – 25 – State Sector Schemes  
SH – 13 – Payment of Ex-gratia to deceased persons due to  
Thunderbolt  
DH – 310 – Grants – in – Aid  
SDH – 312 – Other Grants – in– Aid

6. The Collector & District Magistrate, Mahabubabad is authorized to draw the amount sanctioned in para (4) above and disburse the same to the deceased families through transfer to bank account by way of ECS and utilize the funds for the purpose for which it is sanctioned. And also directed to furnish the Utilization Certificate, duly verified by the State Audit Authorities.

7. The expenditure mentioned in para (4) above is sanctioned as additional fund in relaxation of Treasury Control and quarterly regulation orders by way of obtaining supplementary estimates during FY 2019-20.
