**ORDER:**

In the reference 1<sup>st</sup> read above, the Engineer-in-Chief, RWS&S Department, Hyderabad has requested the additional funds to tune of Rs. 106.791 crores to clear the pending bills under CRF grant and other grant expenditure incurred for tackling the drinking water scarcity in the summer, 2016.

In the reference 2<sup>nd</sup> read above, the Finance (EBS.VII) Department has issued Budget Release Order for an amount of Rs.106,91,00,000/- (Rupees One Hundred Six Crores Ninety One Lakhs only) as additional funds in relaxation of Treasury Control and Quarterly Regulation Orders by way of obtaining Supplementary Grants during the financial year 2017- 18 towards meeting the expenditure to clear pending bills under CRF grant and other grant expenditure incurred for tackling the drinking water scarcity in the summer, 2016.

3. Government after careful examination of the matter, hereby release an amount of Rs. Rs.106,79,10,000/- (Rupees One Hundred Six Crores Seventy Nine Lakhs Ten Thousand Only) from State Disaster Response Fund [SDRF] to the District Collectors in the State to clear pending bills under CRF grant and other grant expenditure incurred for tackling the drinking water scarcity in the summer, 2016.
