ORDER:

In the references 1st to 3rd read above, the Commissioner & Director of Agriculture, Hyderabad has requested to release an amount of Rs.404,58,00,000/-towards input subsidy to the affected farmers whose agriculture crops were damaged due to different natural calamities (Heavy Rains/Floods/Drought/Cyclones) occurred from 2009-10 to 2014-15. - 2. The Finance (EBS.VII) Dept., in the reference 4th read above, issued Budget Release Order (BRO) for an amount of Rs.404,58,00,000/- (Rupees Four Hundred and Four Crores and Fifty Eight Lakhs Only) as additional funds towards input subsidy to the affected farmers whose agriculture crops were damaged due to different natural calamities (Heavy Rains/Floods/Drought/Cyclones) occurred from 2009-10 to 2014-15 in relaxation of Treasury Control and Quarterly Regulation Orders pending provision of funds by way of obtaining supplementary grants during 2014-15.
- 3. After careful examination of the matter, Government hereby release an amount of Rs.404,58,00,000/- (Rupees Four Hundred and Four Crores and Fifty Eight Lakhs Only) from State Disaster Response Fund (SDRF) to the Commissioner & Director of Agriculture, Telangana, Hyderabad, towards input subsidy to the affected Small/ Marginal and Other farmers as per State norms, whose agriculture crops were damaged due to different natural calamities (Heavy Rains/Floods/Drought/Cyclones) occurred from 2009-10 to 2014-15 in relaxation of Treasury Control and Quarterly Regulation Orders pending provision of funds by way of obtaining supplementary grants during 2014-15, subject to conditions that:
 - (i) that payment of input subsidy will be done directly to the bank accounts of farmers which should be Aadhar linked as far as possible.
 - (ii) Payments shall be made within a period of 90 days from the date of release of funds.
 - (iii) Every farmer will be entitled for input subsidy for only one Disaster for the same agricultural season.
 - 4. The expenditure sanctioned in para (3) above shall be debited to the head of Account:

MJH - 2245 - Relief on account of Natural Calamites

SMJH – 02 – Floods, Cyclones etc.,

M.H 101 - Gratuitous Relief

SH (09) - Supply of Seeds, Fertilizers and Agricultural Implements

310 - Grants - in - Aid 312 - Other Grants - in- Aid

5. The Commissioner & Director of Agriculture, Telangana, Hyderabad, is authorized to draw the amount sanctioned in para (3) above and arrange to disburse/distribute the same to the affected farmers through transfer to bank account by way of cheques/ECS and utilize the funds for the purpose for which it is sanctioned.

- 6. The Commissioner & Director of Agriculture, Telangana, Hyderabad, is directed to furnish the District-wise distribution particulars to the Government as well as Director of State Audit, Hyderabad, Telangana urgently.
- 7. The Commissioner & Director of Agriculture, Telangana, Hyderabad, is also directed to furnish the Consolidated Utilization Certificates for the amount sanctioned now duly verified by the Telangana State Audit Authorities. The Commissioner & Director of Agriculture, Hyderabad, shall remit back the unspent balances, if any, forthwith to Government Account.
- 8. The expenditure mentioned in para (3) above is sanctioned in relaxation of Treasury Control and quarterly regulation Orders pending obtaining supplementary grants during 2014-15.
- 9. This order issues with the concurrence of the Finance (EBS.VII) Dept., vide their U.O.No.157/86/EBS.VII/2014, dt. 06.08.2014.
