ORDER:

In the reference 3rd cited, the Commissioner & Director of Agriculture, Telangana, Hyderabad has stated that the BRO and Administrative Sanction Orders issued in the references 1st & 2nd read above pertaining to release of Rs.88,15,11,0000/- (for combined Andhra Pradesh) from SDRF during the financial year 2013-14 towards input subsidy as per state norms to the affected small/marginal and other farmers whose agricultural crops were damaged more than 50% due to heavy rains and hailstorms occurred during 2009-2013, are valid for the financial year 2013-14 only. Hence, the funds cannot be released during this financial year 2014-15, due to lapse of funds by the end of financial year 2013-14 by 31st March, 2014. Therefore, he has requested the Government for issue of revised BRO and Administrative Sanction Orders for release of Rs.75,84,70,000/- for Telangana State for the year 2014-15 towards input subsidy for agricultural crops damaged more than 50% during heavy rains and hailstorms occurred during 2009-2013.

2. The Finance (EBS.VII) Dept., in the reference 4th read above, issued Budget Release Order (BRO) for an amount of Rs.75,84,80,000/- (Rupees Seventy Five Crores Eighty Four Lakhs and Eighty Thousand Only) as additional funds towards input subsidy for Agriculture crop damages due to Hailstorms and Heavy Rains occurred from the years 2009-2013 in relaxation of Treasury Control and Quarterly Regulation Orders pending provision of funds by way of obtaining supplementary grants during 2014-15.

3. After careful examination of the matter, Government hereby release an amount of Rs.75,84,80,000/- (Rupees Seventy Five Crores Eighty Four Lakhs and Eighty Thousand Only) from State Disaster Response Fund (SDRF) to the Commissioner & Director of Agriculture, Hyderabad, towards input subsidy to the affected Small/ Marginal and Other farmers as per State norms, whose agriculture crops were damaged more than 50% due to Hailstorms and Heavy Rains occurred during the years 2009-2013, subject to conditions that :

- i. that payment of input subsidy will be done directly to the bank accounts of farmers which should be Aadhar linked as far as possible.
- ii. Payments shall be made within a period of 90 days from the date of release of funds.
- iii. Every farmer will be entitled for input subsidy for only one Disaster for the same agricultural season.

4. The expenditure sanctioned in para (3) above shall be debited to the head of Account:

MJH	- 2245 - Relief on account of Natural Calamities
SMJH	- 02 - Floods, Cyclones etc.,
M.H 101	- Gratuitous Relief
SH (09)	- Supply of Seeds, Fertilizers and Agricultural Implements
310	- Grants - in - Aid
312	- Other Grants - in- Aid

5. The Commissioner & Director of Agriculture, Telangana, Hyderabad, is authorized to draw the amount sanctioned in para (3) above and arrange to disburse/distribute the same to the affected farmers through transfer to bank account by way of cheques/ECS and utilize the funds for the purpose for which it is sanctioned.

6. The Commissioner & Director of Agriculture, Hyderabad, is directed to furnish the District-wise distribution particulars to the Government as well as Director of State Audit, TS Hyderabad urgently.

7. The Commissioner & Director of Agriculture, Hyderabad, is also directed to furnish the Consolidated Utilization Certificates for the amount sanctioned now duly verified by the Telangana State Audit Authorities. The Commissioner & Director of Agriculture, Hyderabad, shall remit back the unspent balances, if any, forthwith to Government Account.

8. The expenditure mentioned in para (3) above is sanctioned in relaxation of Treasury Control and quarterly regulation Orders pending obtaining supplementary grants during 2014-15.

9. This order issues with the concurrence of the Finance (EBS.VII) Dept., vide their U.O.No.185/44/2014, dt.10.07.2014.
