ORDER:

In the references 6<sup>th</sup> and 7<sup>th</sup> read above, the Finance(EBS.I) Department have issued BROs for an amount of Rs.19200.00 lakh towards 1<sup>st</sup> installment funds and 2<sup>nd</sup> quarter funds for the year 2018-19 under the scheme 'Constituency Development Programme (CDP)' for an amount of **Rs.14490.24 lakh** (Rs.9056.40 lakhs +5433.84 lakh), under General Category, **Rs. 2966.40 lakh** (Rs.1854.00 lakhs +1112.40 lakh) under SCSDf and **Rs.1743.36 lakh** (Rs.1089.60 lakhs + 563.76 lakh) under STSDF for taking up the developmental works in the MLA/MLC Constituencies concerned. Out of which, an amount of Rs.168.00 Crores has been released to the Districts towards 4th quarter funds for the year 2017-18 & 1<sup>st</sup> installment funds for the year 2018-19, vide reference 8<sup>th</sup> read above, for the use of (120) MLAs and (20) MLCs Constituencies.

2. In the reference 3<sup>rd</sup> read above, Government have issued orders for the Hon'ble MLCS nominated by the Hon'ble Governor and elected by the Hon'ble MLAs, need not opt for any district as their Nodal District. Government is the sanctioning authority for the CDP works proposed by the above Hon'ble MLCs and release the funds to the District Collectors concerned for execution.

3. After careful examination, Government hereby release the balance amount of **Rs.24,00,00,000/- such as Rs.15,00,00,000/- (Rupees Fifteen Crore only) @ Rs 75.00 lakh to each of these (20) MLCs (General @ Rs.56,60,250/-, SCSDf @ Rs. 11,58,750/- and STSDF @ Rs.6,81,000/-), towards 4<sup>th</sup> quarter funds for the year 2017-18, and an amount of Rs.9,00,00,000/- (Rupees Nine Crore only) @ Rs 45.00 lakh to each MLA/MLC Constituency (General @ Rs.33,96,150/-, SCSDf @ Rs. 6,95,250/- and STSDF @ Rs.4,08,600/-), towards 1<sup>st</sup> quarter funds for the year 2018-19, from BE 2018-19, to the Director of Economics and Statistics, Hyderabad under Constituency Development Programme(CDP), pertaining to the above (20) Hon'ble MLCs.**

4. The amount released at para-3 above, shall be debited to the following Heads of Account:
