Sub: I&CAD Department - Provision for District Mineral Foundation Trust (DMF) and State Mineral Exploration Trust (SMET) in the Estimate /Revised Administrative Sanction -Clarification - Sought by DWA/TS - Instruction issued for all Engineering Departments - Reg.

The Government vide G.O. 1st cited, have issued orders that an amount equivalent to 10% on Seigniorage charges shall be recovered by the Government, Engineering Departments along with Seigniorage fee from the contractors bills on the quantity of minor minerals consumed in the construction works and the fund collected along with Seigniorage be remitted to the DMF Account directly without routing through consolidated fund of state.

2. Similarly, Industries and Commerce Department vide G.O. 2nd cited have issued instructions to recover an amount equivalent to 2% on Seigniorage fee of all Government Engineering Dept., implementing G.O.Ms.No.94, I&CAD Department, dt: 01-07-2003 from contractors bills and remit to SMET found account.

3. In this regard, the Director of Works Accounts, Hyderabad in his letter 3rd cited has informed that some of the estimating officers are incorporating the provision of DMF and SMET in their estimates work slip and Revised Administrative Sanctions without specific orders of the Government and requested the Finance Department to confirm the action of the estimate sanctioning authorities for providing DMF and SMET in the estimates/ Revised Estimates.

4. In the reference 4th cited, the Engineer-in-Chief (I) has informed that the subject matter was placed before Board of Chief Engineers meeting held on 28-02-2018 and 29-05-2018 and requested to issue specific orders in the matter.

5. The Government after careful examination of the matter, hereby accord permission for provision towards DMF & SMET as a percentage of Seigniorage charges and shall be kept in Part-II of Schedule-A of the Agreement.

6. The Engineer-in-Chief (I), Hyderabad shall take further necessary action accordingly.

7. This order Issues with the concurrence of Finance (W.P) Department vide their U.O.No.0041/70/WP/A2/2018, Dt: 20-12-2018.
