**ORDER:**

The Engineer-in-Chief (R&B), State Roads & CRN has informed that during the review meeting by the Hon' C.M., held on 31-10-2014, it was instructed to commence the works comprising of special repairs and widening of roads from single lane to double lane, duly stipulating the time period allowed from the date of publication of tender notices to the date of receipt of tenders as 7 days instead of 14 days, in relaxation of rule 8(iv) of G.O.Ms.No.94, I & CAD (PW) Dept., Dt.1-7-2003. Hence, he has requested to accord permission accordingly and also requested to ratify his action of calling of tenders for the first lot under Special Repairs.

2. Government after careful examination of the matter, hereby accord permission to the Engineer-in-Chief (R&B), State Roads & CRN to call for Short Tenders allowing time period of 7 days from the date of publication of tender notices to the date of receipt of tenders as 7 days instead of 14 days, in relaxation of rule 8(iv) of the G.O.Ms.No.94, I&CAD (PW-COD) Department, dated.01.7.2003 for all the works except construction of buildings and bridge works costing more than Rs.200 lakhs and also ratify his action of calling of tenders for the first lot under Special Repairs.

3. The Engineer-in-Chief (R&B), State Roads & CRN shall take necessary further action in the matter, accordingly and he shall update the works done in this subject, to Government from time to time.
