## **ORDER:**

In the reference 1<sup>st</sup> read above, Government have issued the Andhra Pradesh State Audit Subordinate Service Rules, 2006 based on the recommendations of One Man Commission.

2. In the reference 2<sup>nd</sup> read above, the Andhra Pradesh State Audit Employees Association has requested to issue suitable amendment to rule 3 of the Andhra Pradesh State Audit Subordinate Service Rules, 2006 to restore the ratio between the promotees and direct recruits for old five point cycle in place of nine point cycle, which was existing prior to the issue of new set of rules in the reference 1<sup>st</sup> read above, so as to protect the interests of the Junior Auditors and Typists for promotion to the higher category of Senior Auditor.

3. In the reference 3<sup>rd</sup> read above, the Director of State Audit while offering his remarks in the matter has recommended to consider the request of the State Audit Employees Association for amendment to rules 3 of Andhra Pradesh State Audit Subordinate Services Rules, 2006. In the reference 4<sup>th</sup> read above, the A.P. Public Service Commission has given their concurrence for the amendment.

4. In the circumstances reported and as recommended by the Director of State Audit in reference 3<sup>rd</sup> read above, Government after careful consideration of the matter and after getting concurrence of A.P. Public Service Commission decided to amend the rules.

5. The following notification will be published in the Andhra Pradesh Gazette.

#### **NOTIFICATION**

In Exercise of the powers conferred by sub-section(1) of section 16 of the Andhra Pradesh State Audit Act, 1989 (Act No.9 of 1989) the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh State Audit Subordinate Service Rules, 2006 issued in G.O.Ms.No.213, Finance (Admn.II) Department, dated 18.07.2006 and as amended from time to time.

#### **AMENDMENT**

In the said rules, under rule 3 for "Note(a) " the following shall be substituted namely:-

"Note(a): The Appointment by the above methods in respect of the posts of Senior Auditors shall be made in a unit of 10 vacancies as follows:

1 <sup>st</sup> Vacancy	Direct recruitment
2 <sup>nd</sup> vacancy	By promotion form the category of Junior Auditor
3 <sup>rd</sup> vacancy	By promotion form the category of Junior Auditor
4 <sup>th</sup> vacancy	Direct recruitment
5 <sup>th</sup> vacancy	By appointment by transfer from the category of Typist
6 <sup>th</sup> vacancy	By promotion form the category of Junior Auditor
7 <sup>th</sup> vacancy	Direct recruitment.
8 <sup>th</sup> vacancy	By promotion form the category of Junior Auditor
9 <sup>th</sup> vacancy	By promotion from the category of Junior Auditor
10 <sup>th</sup> vacancy	By appointment by transfer form the category of Typist

Provided that in every  $2^{nd}$  cycle, the turn at the  $10^{th}$  vacancy shall go to Typist/ Junior Stenographer of the Directorate.
