ORDER:

In the G.O. 1st read above, Government have issued orders for Tender procedures and Registration of Contractors Rules. In the G.O. 2nd read above, amendment orders were issued to Annexure – III of G.O. 1st read above regarding changes in monetary limits, registration fee, solvency certificate and past experience certificate and other requirements. In the G.O.3rd read above, amendments were made to Annexure-II para- I (h) of G.O. 1st cited in respect of Class of contractors and further modification of monetary limits. In the G.O. 4th read above, Government have issued orders enhancing the monetary limits of works for different class of contractors.

2. In the references 5th & 6th read above, the Engineer-in-Chief (I.W) has stated that vide G.O.Ms.No.130, I&CAD (PW: REFORMS) Department, dt: 22.05.2007 (IV) amounts for solvency to be produced are increase due to the increase of Monetary limits at 10% as per G.O.Ms.No.94, dt: 01-07-2003. The subject matter was placed before the Board of Chief Engineers meeting held on 25-05-2015 and then have accepted the proposal for enhancing the amount for which Solvency certificate is to be produced by Contractors. Hence, he has requested the Government duly modifying amount for which solvency certificate is to be produced for CIVIL Category.

3. In the circumstances reported by the Engineer-in-Chief and recommendations of the Committee of Engineers-in-Chief and Board of Chief Engineers, Government after careful examination of the matter issue following amendment to G.O.Ms.No.130, I&CAD (PW: REFORMS) Department, dt: 22.05.2007 for Enhancing Amount of Solvency Certificate to be produced by CIVIL Category Contractors as follows:

“Solvency certificate issued by the Scheduled Bank in the prescribed proforma are only considered for obtaining registration in Govt., of Telangana. The Solvency certificate shall be valid for a period of one year from the date of their issue”.

Note: For other categories such as Public Health Engineering, Furniture, Electrical Transport & Fabrication and erection of structural steel, Amount for which the Solvency Certificate to be produced mentioned in G.O.Ms.No.130, I&CAD (PW: Reforms) Deptment, Dt.22-05-2007 holds good.
