ORDER:

The Engineer-in-Chief(AW), I&CAD Dept., Hyderabad in his letters read above has stated that the Government envisage to give impetus to the Irrigation Potential. The Quality Control is the back bone for successes of the Projects. Quality Control wings were formed from time to time, whenever irrigation projects were taken up in the state. Presently existing quality control circles and Divisions formed for certain Major Irrigation projects entrusted with the work of monitoring of Quality Control of other projects, as and when necessitated. The quality control division jurisdiction presently spread over in (3) to (4) districts. At the same time two QC divisions located in various districts are looking after the QC aspects in one district, which is causing lapses in time, monitoring of the works.

The Engineer-in-Chief(AW),I&CAD Dept., Hyd. has therefore proposed to re-organize the Quality Control unit to have uniform work load and compact jurisdiction for effective monitoring of works and requested to issue orders.

After careful examination of the above proposal, Government hereby Reorganize the Quality Control Unit of Irrigation & C.A.D. Department by keeping the existing two quality control circles i.e., Hyderabad and Warangal under the administrative and technical control of the Chief Engineer, Quality Control, Hyderabad to look after the Quality control aspects of all Major, Medium and Minor Irrigation works including Mission Kakatiya. The unit of Chief Engineer, Quality Control, Hyderabad will function with the following two circles and eight divisions as proposed in the letter 2nd read above, having total cadre strength of (500) posts in different cadres as shown in the Annexure appended to this order.

- 4. Quality Control & Inspection Division No.4, Nizamabad with (4) Sub Divisions.

- 1. Quality Control & Inspection Division No.5, KC Camp, Hanmakonda with (5) Sub-Divisions.
- 2. Quality Control & Inspection Division No.6, Khammam with (4) Sub Divisions.

- 2. Quality Control & Inspection Division No.8, Nirmal with (4) Sub Divisions.

The Engineer-in-Chief (AW), I&CAD Department, Hyderabad is permitted to meet the expenditure not exceeding an amount of Rs.3,50,000/- (Rupees three lakhs fifty thousand only) towards shifting of offices from one place to another place, if any, and also to re-deploy the staff wherever necessary strictly in conformity with the presidential orders. He is also permitted to effect transfer of employees if any, up to his competency, in relaxation of ban on transfers.

The Engineer-in-Chief (AW), I&CAD Department, Hyderabad shall take further necessary action in the matter accordingly.
