**ORDER:**

In the G.O. 1<sup>st</sup> read above, the Government issued orders for constitution of Committee for District Mineral Foundation under Section 9B (1) and 15(4) of Mines & Minerals (Development & Regulation) Amendment Act, 2015. Further, in the G.O.2<sup>nd</sup> read above, certain amendments have been issued to the constitution of Managing Committee for implementation of District Mineral Foundation (Trust) for the implementation of projects under Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY).

2. In the reference 3<sup>rd</sup> read above, the Secretary to Government of India, Ministry of Mines, New Delhi has requested the State Governments to examine the Constitution of Committees for District Mineral Foundation and include the Members of Parliament and Members of State Legislature also as Members of District Mineral Foundation Committees as Public Representatives.

3. In the reference 4<sup>th</sup> read above, the Director of Mines & Geology, Hyderabad submitted the proposals for inclusion of Members of Parliament and Members of State Legislature as Members to the Governing Councils of the District Mineral Foundation (Trust) as Public Representatives.

The Government after careful examination of the matter, hereby decide to include the Members of Parliament and Members of State Legislature as Members to the Governing Council of the District Mineral Foundation (Trust) as Public Representatives along with other public representatives up to the Gram Panchayat of the affected village.
