In the G.O.1st read above, orders were issued extending Pay Scales to all the qualified categories of 5625 employees who are presently working on full time basis in the 646 assessable Institutions, with effect from November,2017. It was also ordered therein that necessary administrative action required in this regard, in respect of 3198 Contract/NMR, Consolidated pay basis, etc., employees, out of the above 5625 employees, who are working on full time basis, may be initiated by the Commissioner of Endowments, including sanction of additional cadre strength to the temples, wherever required, and fixation of pay in relaxation of the existing orders relating to ban on appointments to the extent of the above 3198 employees, as a one-time measure.

2. In pursuance of the above Government order, the Commissioner, Endowments Department in the reference 2nd read above, has requested the Government to issue orders permitting to take action as proposed therein and the relaxations required to implement the orders issued in the above said G.O.

3. Government, after careful examination of the matter, hereby accord permission to the Commissioner, Endowments Department, to consider post-facto relaxation of the procedure prescribed in Rule 46 of the Telangana Charitable and Hindu Religious Institutions and Endowments Office Holders and Servants Service Rules,2000 issued in G.O.Ms.No.888, Revenue (Endts-I) Department, dated 08.12.2000 and the ban imposed vide G.O.Ms.No.1997, Revenue (Endowments. I) Department, dated 18.10.2005 in respect of employees appointed prior to 02.06.2014, including full time employees appointed on Contract/ Consolidated/ NMR basis, as a one-time measure, subject to possession of the qualifications as prescribed under the rules, for the purpose of extension of the pay scales as per G.O.Rt.No.577, Revenue (Endts-I) Dept., dt.15.09.2017. The cut-off date of 02.06.2014 is taken into consideration keeping in view the formation of the new State of Telangana and also several irregular appointments made after the said date in anticipation of regularization. It is also directed that in respect of such of the employees who do not have the requisite qualifications, they may be continued on the existing pay till such time as they acquire the prescribed qualifications.

4. Government also permit the Commissioner, Endowments Department, to prescribe the Schedule of Establishment i.e. cadre strength in respect of each of the (646) assessed institutions under Rule 5 of the Telangana Charitable and Hindu Religious Institutions and Endowments Office Holders and Servants Service Rules,2000 having due regard to the requirement and income of each institution and publish the same, prohibiting any further changes thereto except by the Commissioner wherever the working strength at present in any institution is in excess of the cadre strength so now fixed, the C.E.D. is permitted to treat the such excess strength as supernumerary posts which shall lapse as and when the incumbent thereof is retired or otherwise ceases to be available.
