ORDER:

In the G.O. 1st read above, Government have issued orders for notification of Thunderbolt under the provisions of Special Disasters, within the local context of the State, as State Specific Disaster and fixed the ex-gratia for an amount of Rs.6.00 lakhs to the families of the deceased persons due to Thunder bolt.

In the references 3rd read above, the Collector & District Magistrate, Karimnagar have forwarded the proposals to Government regarding ex-gratia for an amount of Rs.6.00 lakhs to Sri Thedla Saraiah S/o Late Ramaiah died on 10.10.2020 at about 3.30 PM due to hit by Thunderbolt at Bujunnur (Village), Ellandakunta (Mandal), Karimnagar District, as per orders issued in G.O. Ms.No.2, Revenue(DM)Dept., Dt:19.07.2018.

3. After careful examination of the matter, Government hereby sanction an amount of Rs.6.00 lakhs (Rupees Six Lakhs only) towards payment of Ex-gratia Rs.6.00, to Sri Thedla Saraiah S/o Late Ramaiah died on 10.10.2020 at about 3.30 PM due to hit by Thunderbolt at Bujunnur (Village), Ellandakunta (Mandal), Karimnagar District, as per orders issued in G.O. Ms.No.2, Revenue(DM)Dept., Dt:19.07.2018.

4. The expenditure sanctioned in para (4) above shall be debited to the Head of Account:

MJH	– 2245- Relief on account of Natural Calamities
SMJH	– 80 - General
M.H	- 800 - Other expenditure
GSH	- 25 - State Sector Schemes
SH	- 13 - Payment of Ex-gratia to deceased persons due to Thunderbolt
DH	- 310 - Grants – in – Aid
SDH	- 312 - Other Grants – in– Aid

5. The Collector & District Magistrate, Karimnagar is authorized to draw the amount sanctioned in para (4) above and disburse the same to the deceased family through transfer to bank account by way of ECS and utilize the funds for the purpose for which it is sanctioned. And also directed to furnish the Utilization Certificate, duly verified by the State Audit Authorities.

6. The expenditure mentioned in para (4) above is sanctioned as additional funds in relaxation of Treasury Control and quarterly regulation Orders by way of obtaining supplementary estimates during FY 2020-21.
