ORDER:

The post of Village Revenue Officer was abolished, vide reference 4th read above, with a provision that the service of every person working as Village Revenue Officer shall be transferred to and absorbed in any equivalent category in any Government department as per administrative exigencies.

- 2. The Revenue Department, vide reference 5th read above, proposed re-deployment of the services of erstwhile Village Revenue Officers accordingly in the needy departments, as their services have become surplus.
- 3. Government, after careful examination of the matter, hereby authorize the District Collectors to redeploy the services of all the incumbents holding the post of Village Revenue Officer in their district, including those who are on leave/under suspension/deputation/foreign service, in any of the

Government departments in their district, other than Revenue department, as per need, for absorption against regular vacancies in Junior Assistant and equivalent categories. The redeployment shall be subject to availability of vacancies and made in a transparent manner, by drawal of lots.

4. The concerned departments shall admit the individuals as allotted by the District Collector and draw their pay and allowances, from the date of reporting, after obtaining their Last Pay Certificate and Service Register from the concerned Mandal/Unit office of Revenue Department.
