**ORDER:**

Sri Laxmi Narasimha Swamy Devasthanam, Yadagirigutta, Nalgonda District, Sri Raja Rajeshwara Swamy Devasthanam, Vemulawada and Sri Seetarama Chandra Swamy Devasthanam, Bhadrachalam, Telangana State where expenditure on Establishment charges are below 30% or above 30%.

2. In the reference 4th read above, the Temple Employees Associations have represented for implementation of the Pay Revision Commission Scales, 2015 to the employees of Joint Commissioner, Dy. Commissioner, Asst. Commissioner and other cadre temples.

3. Government, after careful examination, hereby order to extend the benefit of PRC Scales, 2015 to the employees who have been working on PRC 2010 scales in the following Joint Commissioner Cadre temples where expenditure on establishment charges is below 30% or above 30%.

1. Sri Lakshmi Narasimha Swamy Devasthanam, Yadagirigutta, Nalgonda district;
2. Sri Raja Rajeswari Devasthanam Vemulawada, Karimnagar District and
3. Sri Sita Rama Chandra Swamy Devasthanam, Bhadrachalam, Khammam district.

4. The date of effect of implementation of the PRC 2015 scales to the above said temple employees, with regards to notional/ monetary benefits shall be the same as that of Government employees.

5. The Commissioner of Endowments Department, Telangana, Hyderabad is requested take necessary action accordingly in the matter.
