ORDER

In the reference 1st read above, Joint Advisor, National Disaster Management Authority, Government of India, New Delhi has informed that all the States/UT shall notify a Committee at District level for issuance of the Official Document for COVID-19 death and payment of Rs.50,000/- as an ex-gratia to next kin of the deceased persons due to COVID-19 from State Disaster Relief funds in the light of the orders of the Hon'ble Supreme Court of India dated 30.06.2021 in WP© No.554/2021 & 539/2021. In the G.O.2nd read above, Government have constituted the District level Committee for issuing of official document for COVID-19 death to the next kin of the deceased.

2. In the G.O.3rd read above, Government have issued guidelines for payment of ex-gratia of Rs.50,000/- to the next kin of deceased who died due to COVID-19 from SDRF.

3. In the G.O.4th read above, the Finance (EBS.VII) Department, has issued BRO for an amount of Rs.20.58 Crores (Rupees Twenty Crores Fifty Eight Lakhs only as additional funds in relaxation of Treasury control orders and quarter regulation orders by way of obtaining supplementary grants at the appropriate time during the FY 2021-22 towards meeting the expenditure for ex-gratia payment of Rs.50,000/- each to the kin of deceased persons(4116), who died due to Covid-19

4. After careful examination, Government hereby sanction an amount of Rs.20.58 Crores (Rupees Twenty Crores Fifty Eight Lakhs only), and release the ex-gratia payment of Rs.50,000/- each to the accounts of the families of the deceased persons(4116), who died due to COVID -19 (beneficiaries i.e. as per list available from Mee-seva portal, after verification of District Level CoVID-19 death Ascertaining Committee (CDAC)).

5. The expenditure sanctioned in para (4) above shall be debited to the head of Account:

MJH	-	2245	-	Relief on account of Natural Calamities
SMJH	-	02	-	Floods, Cyclones, etc.
M.H	-	111	-	Ex-gratia payment to bereaved families
GSH	-	25	-	State Sector Schemes
SH	-	04	-	Ex-gratia payment to bereaved families
DH	-	310	-	Grants – in – Aid
SDH	-	312	-	Other Grants – in– Aid

6. In the first instance, the Drawing and Disbursing Officer (DDO), Revenue(DM)Department, Telangana Secretariat is authorized to draw and disburse the above said amount, to the deceased families(beneficiaries list enclosed) through transfer to bank account by way of ECS.

7. The Collector & District Magistrates in the State are directed to furnish the Utilization Certificate, duly verified by the State Audit Authorities.

8. This order issues with the concurrence of the Finance (EBS.VII) Department vide their U.O.No.1388849/04/EBS.VII/Rev/2022, dt.11.01.2022.
