In the G.O. 4th read above, the Finance (EBS.VII) Department have issued BRO for an amount of Rs. 25,87,000/- (Rupees Twenty Five Lakh and Eighty Seven thousand only) as additional funds in relaxation of Treasury Control orders and quarterly regulations orders by way of obtaining supplementary estimates during the FY 2021-22 towards Hand sanitizors, hand gloves, face masks for use of the officers and staff in Secretariat.
- 1. After careful examination of the matter, Government hereby sanction an amount of Rs.25,87,000/- to General Administration Department towards expenditure of Hand sanitizers, Hand Gloves and facemasks for use of the officers and staff in Secretariat under the COVID-19 Pandemic Scheme.
