ORDER:

In the reference 1st read above the Secretary to Government HM & FW Department has requested to accord administrative sanction for an amount of Rs. Rs.53,58,20,000/- towards providing single and triple line centralized medical gas pipeline system in 133 hospitals under control of DME, TVVP and DPH& FW to accommodate patients of Covid-19 and also requested to authorize the DME to draw and disburse the amount to the bank account of Managing Director, TSMSIDC, Hyderabad as mention in BRO.

In the reference 2nd read above Finance (EBS-VII) Department has issued BRO for an amount of Rs.53,58,20,000/- (Rupees Fifty Three Crores Fifty Eight Lakhs and Twenty Thousand Only) as additional funds in relaxation of treasury control and quarterly regulation orders by way of obtaining supplementary estimates during the Financial year 2021-22 towards meeting the expenditure for single and triple line centralized medical gas pipeline system to 9726 beds in 133 hospitals under control of DME, TVVP and DPH& FW to effective management of Covid-19.

After careful examination of the matter Government hereby sanction an amount of Rs.53,58,20,000/- (Rupees Fifty Three Crores Fifty Eight Lakhs and Twenty Thousand Only) to the Managing Director, Telangana State Medical Services Infrastructure Development Corporation (TSMSIDC) as additional funds towards meeting the expenditure for providing of single and triple line centralized medical gas pipeline system to 9726 beds in 133 hospitals under control of DME, TVVP and DPH& FW to accommodate patients of Covid-19.

The Director of Public Health, Hyderabad is authorized to draw and disburse the amount to the bank account of Managing Director Telangana State Medical Services Infrastructure Development Corporation (TSMSIDC) as mentioned by the Secretary to Government Secretary Health Medical and Family Welfare Department and also requested to furnish the consolidated Utilization Certificates for the said amounts to the State Audit Authorities
