**ORDER:**

In the reference 1<sup>st</sup> read above the Secretary to Government HM & FW Department has requested to accord administrative sanction to the MD, TSMSIDC vide G.O.Rt.No.404, HM & FW (C2) Dept., dated:23.06.2021, towards procurement of equipment, surgical, consumables & drugs for upgrading paediatric centres across the state in preparation for possible surge in paediatric cases in 3<sup>rd</sup> wave of Covid-19. And also authorized the Director, Medical Education, Hyderabad to draw and disburse the amount to the bank account of the Managing Director Telangana State Medical Services Infrastructure Development Corporation (TSMSIDC).

In the reference 2<sup>nd</sup> read above Finance (EBS-VII) Department has issued BRO for an amount of Rs.133,90,25,256/- (Rupees One Hundred and Thirty Three Crores Ninety Lakhs Twenty Five Thousand Two Hundred and Fifty Six Only) as additional funds in relaxation of treasury control and quarterly regulation orders by way of obtaining supplementary estimates during the Financial year 2021-22 towards meeting the expenditure for procurement of equipment, surgical, consumables & drugs for upgrading paediatric centres across the state in preparation for possible surge in paediatric cases in 3<sup>rd</sup> wave of Covid-19.

After careful examination of the matter Government hereby sanction an amount of Rs.133,90,25,256/- (Rupees One Hundred and Thirty Three Crores Ninety Lakhs Twenty Five Thousand Two Hundred and Fifty Six Only) to meet the expenditure for procurement of equipment, surgical, consumables & drugs for upgrading paediatric centres across the state in preparation for possible surge in paediatric cases in 3<sup>rd</sup> wave of Covid-19.
