ORDER:

In the reference 1st read above, the Director of Public Health and Family Welfare, Hyderabad has requested to accord administrative sanction for an amount of Rs.1,48,32,000/- (Rupees One Crore Forty Eight Lakhs Thirty Two Thousand Only) to the Director, ICMR-NIN, Hyderabad towards conducting community Based Sero-Surveillance of Sars-Cov-2 infection in 32 Districts of Telangana except Hyderabad.

In the G.O. 2nd read above, Finance (EBS-VII) Department have issued BRO for an amount of Rs.1,48,32,000/- (Rupees One Crore Forty Eight Lakhs Thirty Two Thousand Only) as additional funds in relaxation of treasury control and quarterly regulation orders by way of obtaining supplementary estimates during the Financial year 2021-22, towards conducting community Based Sero-Surveillance of Sars-Cov-2 infection in 32 Districts of Telangana except Hyderabad.
