ORDER:

In the references 2nd to 8th read above, the Collector & District Magistrates of Jagtial, Khammam, Mahabubabad, Nirmal, Vikarabad, Wanaparthy & Yadadri Bhuvanagiri, have forwarded the proposals to Government regarding ex-gratia for an amount of Rs.6.00 lakhs each, to the families of deceased persons , who were died due to Thunderbolt, as per orders issued in G.O.
