**ORDER:**

In the reference 1<sup>st</sup> read above the Secretary to Government HM & FW Department has requested to accord administrative sanction for an amount of Rs.24,60,78,189/- to the MD, TSMSIDC, towards procurement of certain drugs, consumables and equipment as part of the Preparedness for the possible surge of Covid cases during 3<sup>rd</sup> wave.

After careful examination of the matter Government hereby sanction an amount of Rs.24,60,78,000/- (Rupees Twenty Four Crores Sixty Lakhs Seventy Eight Thousand Only) to the MD, TSMSIDC, Hyderabad to meet the expenditure for procurement and supply of the equipment, consumables, drugs as part of the Preparedness for the possible surge of Covid -19 cases during 3<sup>rd</sup> wave.
