ORDER

In the reference read above, the Commissioner of GHMC, Hyderabad has stated that the series of floods in Hyderabad during October 2020 has resulted in inundation of many low-lying areas, damage to civic infrastructures as well as damage of houses in the GHMC. In view of this, GHMC has taken immediate relief and rescue measures by arranging relief camps/shelters etc. to families affected due to incessant rains. Further, as per request of GHMC, the Telangana State Handloom Weavers Cooperative Society Ltd.(TSCO), Hyderabad, Sri Laxmi Venkateswra Wool Industrial Co-Operative Production & Sales Society Ltd., Mahabubnagar District and the Wool Industrial Co-op Society Ltd., Veltoor, Wanaparthy District have supplied blankets, to distribute the same to people staying in GHMC shelter homes and relief camps. Details are as follows:

After careful examination of the proposal of the Commissioner of GHMC, Hyderabad, Government, hereby sanction for an amount of Rs.6,32,11,400/- to the Commissioner of GHMC, Hyderabad towards payment to the Cooperative Societies for supplying blankets, in the shelters & relief camps, during the floods in the month of October 2020 from Corporate Social responsibility (CSR) funds under State Disaster Management Authority (SDMA) funds. The amount of Rs.6,32,11,400/- (Rupees Six Crore Thirty Two lakh eleven thousand and four hundred only) is credited to the Commissioner of GHMC, Hyderabad in **Bank A/C No.52082155599, IFSC:SBIN0020432, Branch, Hyderabad**, vide transaction UTR No.SBINR(J) 79522307, dated: 23.12.2021 from A/c.62036415833, SBI Secretariat Branch.

4. The Commissioner of GHMC, Hyderabad is requested to furnish the utilization certificate for the amounts sanctioned now to the State Audit Authorities and also requested to refund the unspent balance.
