ORDER

1. In the reference 2nd read above, the Revenue (DA-CMRF) has issued administrative sanction orders for an amount of Rs.7,95,00,000 /- towards payment of ex-gratia of Rs.6,00,000/- to 133 families of farmers who have committed suicide due to failure of agriculture in the state.
2. After careful examination, Government hereby sanction an amount of Rs.7,95,00,000 (Rupees Seven Crores and Ninety Five Lakhs only), and release this amount as ex-gratia payment of Rs.6,00,000/- each to the (133) families of farmers who have committed suicide due to failure of agriculture in the state (beneficiaries as per the appended Annexure).
3. The expenditure sanctioned in para (2) above shall be debited to the head of Account:

MJH	- 2235 – Social Security and Welfare
SMJH	-04 – Debt Relief/waver of Agricultural Loans
M.H	- 101 – Debt Relief/waver of Agricultural Loans
GSH	- 25 – State Sector Schemes
SH	- 05 – Debt Relief to Farmer Suicide Cases.
DH	- 310 – Grants – in – Aid
SDH	- 312 – Other Grants – in– Aid

4. The Collector & District Magistrates in the State as indicated in the Annexure, are authorized to draw the amount sanctioned in Para (3) above and disburse the same to (133) families of farmers who have committed suicide due to failure of agriculture in the state (beneficiaries as per the appended Annexure) through transfer to bank account by way of ECS and utilize funds for the purpose for which it is sanctioned and also directed to furnish utilization certificate, duly verified by the State Audit Authorities.
5. This order is issued with the concurrence of the Finance (EBS.VII) Department vide their B.R.O.No.1682 , dt.24.12.2021.


