ORDER:

The Managing Director, Telangana State Medical Service & Infrastructure Development Corporation (TSMSIDC), Hyderabad vide reference 3rd read above, requested to sanction administrative sanction for an amount of Rs.7025.70 lakhs (Rupees seven thousand and twenty five lakh and seventy thousand only) towards the procurement of 15,00,000 Nos. of Rapid Antigen Testing Kits for Covid-19, indented by the Director of Public Health, Hyderabad to meet the testing kits for Covid-19, is being carried out throughout the State, duly meeting the expenditure from the State Disaster Response Fund (SDRF).

2. In the reference 4th read above, Government have issued administrative sanction for an amount of Rs.20.00 crores (Rupees Twenty crores only) in the first instance towards procurement and supply of 15,00,000 Nos. of Rapid Antigen Testing Kits for Covid-19, and supply to Director of Public Health, Hyderabad under State Disaster Response Fund (SDRF).

3. In the reference 5th read above, the HM & FW (C) Deptt., have requested to issue revised Administrative Sanction to G.O.Rt.No.56, Rev.(DM) Deptt., dt.21.10.2020 towards procurement 19,49,773 Nos. of kits Rapid Antigen Testing Kits for Covid-19, instead of 15 lakhs kits with the same amount of Rs.7025.70 lakh to supply to the Director of Public Health, Hyderabad under State Disaster Response Fund (SDRF).

4. In the circumstances reported by the HM & FW (C) Department vide reference 5th read above, after careful examination of the matter, Government hereby issue the revised Administrative Sanction orders towards procurement of 19,49,773 Nos. Rapid Antigen Testing Kits for Covid-19, instead of 15 lakhs kits with the same amount of Rs.7025.70 lakh and also to permit to the Managing Director, Telangana State Medical Service & Infrastructure Development Corporation (TSMSIDC) to supply Rapid Antigen Testing Kits for Covid-19, 19,49,773 Nos of Kits, the Director of Public Health, Hyderabad under State Disaster Response Fund (SDRF).
