ORDER:

In the G.O. 1st read above, as a part of the COVID-19 relief operations, the Health & Medical Department staff, sanitation Employees of various Municipal Corporations, Municipalities, Sanitary and Multipurpose workers of Gram Panchayats Water Supply Linemen and Sewerage workers of HMWS&SB are rendering service in controlling the epidemic and ensuring uninterrupted civic services to the citizens in difficult circumstances. The Government in reorganisation of the services of Health, Medical, Sanitary and other related employees who are attending COVID-19 relief operations, have decided to grant a onetime monetary incentive as a token of encouragement. According, Government have sanctioned payment of one time Chief Minister Special incentive to all regular and outsourced sanitation employees/personnel of all Municipal Corporations and Municipalities other than GHMC @ R.5000/-.

2. In pursuance of orders issued in the G.O. 2nd read above, the Finance (EBS.VII) Department have issued BRO for an amount of Rs. 1614.83 lakhs as additional fund in relaxation of Treasury Control and quarterly regulations orders by way of obtaining supplementary estimates during the FY 2020-21 towards meeting the expenditure for sanction of one time Chief Minister's Special Incentive to all regular and outsourced sanitation employees /personnel of all Municipal Corporations and Municipalities @ Rs.5000/- other than GHMC, who have actually attended duties of COVID-19 relief operations under the SDRF.

3. After careful examination of the matter Government hereby sanction an amount of Rs. 1614.83 lakhs (Rupees Sixteen Crores Fourteen Lakhs Eighty Three Thousand only) for sanction of one time Chief Minister's Special Incentive to all regular and outsourced sanitation employees /personnel of all Municipal Corporations and Municipalities other than GHMC @ Rs.5000/- , who have actually attended duties of COVID-19.

4. The expenditure sanctioned in para (3) above shall be debited to the head of Account:

MJH	- 2245 - Relief on account of Natural Calamities
SMJH	- 80 - General
M.H	- 800 - Other expenditure
GSH	- 25 - State Sector Schemes
SH	- 14 - COVID-19 Pandemic
DH	- 500 - Other Charges
SDH	- 503 - Other Expenditure

5. The above incentive is to be drawn and paid to only those employees and persons who have actually attended to duties during the month of March and not to those who are on leave, suspension or unauthorised absence. The expenditure towards the Incentive shall be met from the releases made by the Government for COVID-19 relief operations.

The Commissioner & Director of Municipal Administration, Hyderabad is requested to direct the concerned DDOs that these amounts are drawn in strict compliance of the above instructions and any excess payments done would be dealt with seriously and also requested to obtain and furnish the consolidated Utilization Certificates for the said amounts to the State Audit Authorities.
