Sub: Public Services-Treasuries and Accounts Department-Pay Fixation formula for conversion of RPS, 2015 state scales to UGC, 2006 Scales-Reg.

Ref: Lr.No.F2/6770/2020, Dated.24.11.2021 of the Director of Treasuries and Accounts, Telangana, Hyderabad.

The attention of the Director of Treasuries and Accounts, Telangana, Hyderabad is invited to the reference cited. He is informed to follow the fixation formula for conversion of pay from RPS, 2015 state scales to UGC 2006 scales, as prescribed in G.O.Ms.No.12, Higher Education (CE) Dept., dt:10.02.2021, as follows,

**Fitment formula:**

- "From the basic pay being drawn in the State RPS 2015 as on the date of promotion after fixation as per the F.R 22 (a) (i) and F.R 22 (b) as applicable, merged elements D.A 63.344%, Fitment 43% should be arrived first and the same amount shall be deducted from the basic pay in the state RPS 2015. This arrived amount shall be taken as 2010 State RPS basic pay, be converted to UGC Pay Scales 2006 as per the G.O.Ms.No.01, HE (CE-1), dated 08.01.2015, i.e., the D.A difference 28.26% of basic pay as On 01.07.2008 should be arrived first (DA element merged as on 01.07.2008 i.e., 42.39% of basic pay - DA allowed as on 1.1.2006 i.e., 14.13% of basic pay) and shall be deducted from the basic pay of State RPS 2010 arrived above, balance of the thus arrived shall be taken for the purpose of fixation in UGC Pay Scales, 2006. The pay shall be fixed in the Pay Band of Rs 15600- 39100+6000 AGP at the stage above the grade pay in the Pay Band+ AGP".
  - Earlier to the above said GO, orders were Issued vide G.O.Ms.No.01, HE(CE-1), dated 08.01.2015 for Pay fixation formula for conversion of RPS 2005 & 2010 to UGC 2006 Scales, which are as mentioned below:

**Formula-I**

For those doctors recruited on or after 01.01.2006 and drawing state pay scales, 2005 and qualified for UGC pay scales, 2006:

From the basic pay drawn in the State Pay Scales, 2005 as on the date of promotion to the post carrying the revised UGC Pay Scales, 2006. D.A. element merged as on 01.07.2003 (30.266%) and D.A. element allowed as on 01.01.2006 (14.130%) should be arrived first i.e. (16.136%) and shall be added to the basic pay (State Pay Scales) as on the date of promotion/eligibility to UGC Pay Scales, shall be taken as basic pay for the purpose of fixation of pay in the Revised UGC Pay Scales, 2006. The pay shall be fixed in the pay band of Rs.15,600-39,100+6000 AGP at the stage above the grade pay in the pay band.

**Formula - II**

For those doctors who were appointed after 1.7.2008 drawing state pay scales, 2010 and qualified for UGC pay scales, 2006:

From the basic pay being drawn in the State Pay Scales, 2010 as on the date of promotion to the post carrying the revised UGC Pay Scales, 2006. D.A. element merged as on 01.07.2008 (42.39%) and D.A. allowed as on 01.01.2006 (14.130%) should be arrived first i.e. (28.26%) shall be deducted from the basic pay and the balance of basic pay (State Pay Scales) thus arrived at, shall be taken as basic pay for fixation of pay in UGC Pay Scales, 2006. The pay shall be fixed in the pay band of Rs.15,600-39,100 + 6000 AGP at the stage next above the grade pay in the pay band + AGP.

2. The Director of Treasuries and Accounts, Telangana, Hyderabad shall take necessary action, accordingly.
