Attention is invited to the subject and references cited wherein the Government have issued orders for implementation of Revised Pay Scales – 2020 to (2641) Archakas, other office holders and servants who are drawing salaries under Grant-in-Aid vide reference 2nd cited.

In view of the above, G.O.Ms.No.114, Revenue (Endts.I) Department, dt.03.12.2021 is herewith communicated. All the Executive Officers/Executive Authorities are directed to adhere the following procedural instructions in addition to the instructions issued in the reference 3rd cited for pay fixation in RPS-2020 to the (2641) Archakas, other office holders and servants who are drawing salaries under Grant-in-Aid which are follows.

- a) The Deputy Commissioner & E.O of Sri Ganesh Temple, Station Road, Secunderabad, the Assistant Commissioners & Executive Officers and all the E.Os & Executive Authorities are directed to update the Service Registers of Archaka & other employees who are drawing salary from G.I.A fund.
- b) After updation of service registers of the employees, Pay Fixation Proceedings in RPS-2020 should be issued by the concerned Executive Officers and with the scrutiny/verification of the State Audit Department/Local Fund Audit Department.
- c) Scrutinized proceedings by the State Audit Department/Local Fund Audit Department should be submitted to this office along with Xerox copy of SR entries on or before 21.01.2022 with the attestation of the District Assistant Commissioner.
- d) The Deputy Commissioner & E.O of Sri Ganesh Temple, Station Road, Secunderabad and the Assistant Commissioners & Executive Officers of the temples are instructed to follow the above procedure duly attested by the Nodal Officers (Deputy Commisisoner).
- e) The RPS-2020 will be implemented to the above (2641) employees of Archakas & other office holders and servants who were covered in Aug-2021 salary bill under Grant-in-Aid only.

- f) In case of any erroneous pay fixations are detected, action will be taken against the concerned Executive Officer/Executive Authority.

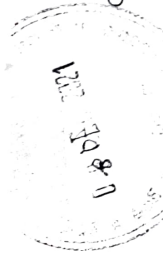
