In the reference 2<sup>nd</sup> read above, the Telangana Non-Gazetted Officers' Union Central- Hyderabad have represented to the Commissioner, Endowments Department, Telangana State, Hyderabad and requested for implementation of the Pay Revision Commission Scales, 2020 to the employees of Joint Commissioner, Dy.Commissioner, Asst.Commissioner and other cadre temples.
- 3. In the circumstances reported by the Commissioner, Endowments Department, Hyderabad in the reference 3<sup>rd</sup> read above, Government after careful consideration, hereby order to extend the Revised Pay Scales, 2020 to the employees and Archakas of temples working in the Joint Commissioner Cadre temples having below 30% or above 30% establishment charges and Deputy Commissioner / Assistant Commissioner cadre temples and other temples having 30% and below establishment charges, as per section 57 of the act 33/2007.
- 4. The date of effect of implementation of the Revised Pay Scales, 2020 to the above temple employees and Archakas with regards to notional / monetary benefits shall be the same as that of Government employees.
- 5. The Commissioner of Endowments Department, Telangana, Hyderabad is requested to take necessary action accordingly in the matter.
