The attention of the Commissioner of Endowments Department, A.P., Hyderabad is invited to the references cited and he is informed that the Government after having detailed discussions with the Commissioner of Endowments/ Additional Commissioners of the Department vide the references 3<sup>rd</sup> and 4<sup>th</sup> cited and also after careful examination of the recommendation of the committee on extension of the benefit of PRC 2010, hereby decide to issue the following instructions for working out the establishment charges in all the temples under the control of the Endowments Department:

1. The establishment charges shall be worked out duly excluding the charges payable to Police, SPF, Home-guards and Security guards;
2. The establishment charges shall be worked out duly excluding the costs on pension;
3. The establishment charges shall be worked out duly excluding the remuneration payable to Contract / Consolidated/ N.M.R. / Out Sourcing/ Work Charged/ Daily Wages in implementing 2010 P.R.C. to Joint Commissioner/ Deputy Commissioner/ Assistant Commissioner cadre temples / and other temples. However, this expenditure shall be met with from the respective maintenance heads such as Health and Sanitation, Water supply, gardening etc.,
4. Employees working on deputation / transfer from other than the cadre of such temples may be repatriated to their parent institutions. However, if their services are required, their salary expenditure shall be borne by their respective parent institutions.
